AND UPON it being advisable to issue an order pursuant to the *Provincial Court Act*, RSA 2000, c P-31, s 8, 9 and 64; the *Provincial Court Civil Procedure Regulation*, Alta Reg 176/2018, s 12, the *Interpretation Act*, RSA 2000, c I-8, s 28(1)(w); the *Interpretation Act*, RSC 1985, c I-21, s 35(1); the *Criminal Code*, RSC 1985, c C-46, s 601(3)(c), (8); *Court Rules and Forms Regulation*, Alta Reg 39/2002 at s 2(1) and Rule 1.4(1) of the Alberta Rules of Court amending the style of cause in all proceedings in the Court;

IT IS ORDERED:

- Subject to any order in any particular proceeding to the contrary, all styles of cause that name as a party Her Majesty the Queen are deemed to be amended to refer to His Majesty the King.
- 2. Subject to any order in any particular proceeding to the contrary, all styles of cause that name as a party Her Majesty the Queen in right of the Province of Alberta are deemed to be amended to refer to His Majesty the King in right of the Province of Alberta.
- 3. Subject to any order in any particular proceeding to the contrary, all styles of cause that name as a party Her Majesty the Queen in right of Canada are deemed to be amended to refer to His Majesty the King in right of Canada.
- 4. All styles of cause that refer to "Regina" are deemed to be amended to refer to "Rex".
- 5. This order applies to any pleading or indictment that refers to Her Majesty the Queen in any way, notwithstanding any variation in the wording used.
- 6. Nothing in this order requires the amendment, refiling or endorsement of any document previously filed with the Court.
