## **Crown Time Estimates**

Crown has the ability now to record Crown Time Estimate in the Crown File Management system for the following appearance types: bail hearing, summary disposition, preliminary hearing and trial.

Crown Time Estimate values are shared with RCS for informational purposes only so that defence counsel is aware of how much time does Crown require for their case.

Crown Time Estimate is displayed in the Requirements screen once the appearance type is selected. CASS user is still required to select the time required for the hearing booked.

## **Default values in RCS**

Certain combinations of booking types and appearance types have a default value for the amount of time required that cannot be changed.

For example if Bail Hearing is selected for both Booking Type and Appearance Type, then the amount of Time required defaults to 1 Case and cannot be changed.
