Case Management Office

The Case Management Office (CMO) will remain closed to all in-person appearances unless otherwise authorized by the Court. All appearances by self-represented litigants and by counsel will be by remote appearance only via email or telephone pursuant to the <u>Case Management Office</u> (CMO) and Out-of-Custody Docket Court Resumption Protocol.

Self-Represented Individuals

Self-represented individuals must appear in person for trials, preliminary inquiries and all other hearings as scheduled unless advised otherwise, or as may be superseded by Provincial Court of Alberta COVID-19 protocols from time to time. Docket appearances are required and are to be made remotely. Dockets:

All docket courts (Criminal, Family, Child Enhancement, Civil, and Youth) will be held remotely. No in-person appearances are allowed unless with permission of the court.

Drug Treatment Court: 1st and 3rd Wednesday at 2 p.m. Youth: 2nd and 4th Wednesday at 1:30 p.m. Family: Thursdays at 9:30 for self-represented individuals and 1:30 for lawyer matters

Medicine Hat

Youth: Mondays at 1:00 p.m. Family: Tuesdays at 10:00 a.m. Drug Treatment Court: 2nd and 4th Wednesday at 2 p.m.

Civil docket matters: as scheduled by the clerk's office

These will proceed by remote appearance only unless other directed by the Court.
