**Judicial Dispute Resolution Booking Procedures
Calgary & Edmonton
Fall Term (September - December 2019)**

The following procedures will apply for this purpose:

1. The list of available dates and assigned JDR Justices for EDMONTON and CALGARY have now been posted on this website.
2. **Please Note:** Family Law JDRs are only available on **Tuesdays before the Family Resolution Judge** pursuant to the June 20, 2018, Notice to the Profession & Public – Family Resolution Project & Mandatory Family Pre-Trial Conferences (NPP #2018-03), which is available [here](#).
3. No bookings will be permitted until 7:30 a.m. on Wednesday, June 5, 2019.
4. Bookings **must**:
 - (a) be made by completing, in full, the JDR Booking Request Form, which is located on the Alberta Courts Website. ****Please note that all fields on the form are mandatory - as such, if the form is not completed in full, it cannot be submitted;**
 - (b) by e-mail of the attached request form, which must relate to one JDR only; and
 - (c) please submit your request only in accordance with the booking priority in paragraph 5.
5. Booking priority will be given:
 - (a) to Family Law matters before the Family Resolution Judge; and
 - (b) to all civil cases that are ready for trial (with a filed Form 37, duly executed by all parties attached).

Note: Please indicate in your “SUBJECT” line whether your booking priority is under (a) or (b) above and a brief Style of Cause and action number.

6. Forms received prior to the 7:30 a.m. booking start time will not be considered and may be deleted. The JDR Coordinator will be in touch with booking parties within 3 weeks after booking commences to advise you of whether and when your matter has been booked, so please provide all contact information in your booking form.
