

Reset/Save/Print Buttons

There are three buttons at the bottom of this form that will perform various actions:

Process for Submission

1. The form is to be filled out by the assigned Crown. The file name of the form must be in the following format:

Last Name of Accused(s) – Docket Number.pdf

2. Two weeks prior to the scheduled PTC, the form is to be sent from the Crown (with their portion filled out and still in a fillable format) to Defence. **If there are multiple accused, please complete one form for each accused. These will then be combined into one file by the Court Coordinator once they are received.**

3. One week prior to the scheduled PTC, the form is to be submitted by the Defence via e-mail (remaining in a fillable format and with a copy to Crown and any other Defence counsel on the matter) to the appropriate jurisdiction. Forms are to be submitted to the appropriate email address below:

4. Once received, the Coordinator will provide a fillable copy of the form (with Crown and Defence remarks) to the assigned Pre-trial Conference Justice. The PTC Justice will fill in the form during the conference and a final copy will then be provided to both counsel and the Court Coordinator by the Justice's assistant.

5. The Court Coordinator will provide a copy of the PTC Report (with the sentencing pages removed) to the assigned Trial Justice prior to the trial.
